LPO Conducting Fellowship 2027/28 – Information for Applicants

The London Philharmonic Orchestra is delighted to invite applications to our **Conducting Fellowship** for the 2027/28 season. This flagship programme seeks to support the development of the world-class conductors of the future, through offering an intensive opportunity to work closely with the Orchestra to **up to two** outstanding early-career conductors from backgrounds currently under-represented in conductors of professional, world-class orchestras.

We believe that talent is indiscriminate, yet people from certain backgrounds and communities continue to be under-represented in the orchestral sector. The LPO Conducting Fellowship aims to promote diversity and inclusivity in classical music as a whole, to lead eventually to a sector that is more reflective of the wider population. We invite applications from conductors from historically under-represented communities in terms of race, sex, gender identity, socio-economic backgrounds, neurodiversity, disability or other under-represented group. Providing artistic and professional development experiences at the highest level of excellence to early-career conductors from under-represented backgrounds is an important goal of the programme.

What is included in the Fellowship?

Guided by the LPO's Principal Conductor, Edward Gardner, the Fellow Conductor(s) will become immersed in the life of the Orchestra, getting to know players, artists and staff, developing skills and knowledge, and broadening their professional network. The LPO prides itself as being a welcoming and supportive orchestra and sets out to ensure the Fellow Conductor(s) become embedded in the LPO community. They will be invited to attend rehearsals and concerts conducted by the Principal Conductor and other conductors, and will also be offered conducting opportunities with the LPO and its Rising Talent ensembles.

The LPO Conducting Fellowship will include:

- Opportunities to conduct the Orchestra in regional and offsite performances, in educational programmes, and ensembles of its Rising Talent programmes
- Assisting opportunities and mentorship with Edward Gardner
- Full immersion into the life of the Orchestra during the period of the Fellowship, with the aim of forming the basis of a longer-term professional relationship

In addition, and considering the individual needs of the Fellow Conductor(s), the Fellowship may also include:

- Assisting opportunities and 1-1 sessions with other LPO titled and guest conductors
- Feedback from LPO musicians
- Meetings with LPO's resident and featured composers
- Professional development opportunities through sessions with LPO personnel, visiting artists and access to the LPO's wide network of industry professionals
- Opportunities to participate in wider LPO promotional activity such as pre-concert talks and social media activity
- Additional tailored support around navigating the barriers specific to the Fellow Conductor

Fees will be paid at the LPO prevailing rates for early-career conductors, and contribution towards travel and accommodation will be provided if required for non-UK based conductors.

Who can apply?

The LPO is committed to advancing equality and inclusive practice in all areas: recruitment, artistic programme, and working environment. **The Conducting Fellowship is open to applicants from backgrounds which are currently under-represented in conductors of professional, world-class orchestras.** We ask applicants to self-identify their eligibility in this area. Eligible criteria may include, but are not limited to, under-represented racial, ethnic or socio-economic backgrounds, and may also include sex, gender, neurodiversity and disability.

We particularly welcome applications from candidates who are:

- from the global majority (this includes, but is not limited to people of Black African, Black British, Black Caribbean, South Asian, East Asian, South East Asian, Middle Eastern, Arab and Latinx backgrounds, as well as people indigenous to the global south)
- female
- trans or non-binary
- Disabled

as they are currently under-represented among the conductors we work with.

Applicants must be able to demonstrate extensive background and training in orchestral conducting, and be able to demonstrate ability in developing and conducting programmes, excellent musicianship, and communication skills.

Applicants must be over 18 and not in full-time undergraduate education. UK-based conductors are strongly encouraged to apply and will be prioritised.

Application requirements including audition information are outlined below.

What is the selection process?

All online applications will be reviewed by the LPO's artistic team. Successful applicants will then be invited for a live audition in London. Applicants who attend the live audition will have the opportunity to conduct the Orchestra in rehearsal, and all musicians will be invited to provide feedback. The committee on the audition day will include the LPO's Artistic Director, Principal Conductor, a board member and a number of LPO musicians, who will then identify the conductor(s) to be offered Fellowship positions for the 2027/28 season. The LPO will seek to ensure that a diversity of backgrounds are represented among the selection committee.

Feedback

Due to the anticipated high number of applications, we are unable to give individual feedback to applicants who are not offered an audition. Applicants who take part in the audition may request feedback within a given deadline.

Key dates

- Applications open: September 2026
- Deadline to submit applications: **9:00AM (UK time) on Monday 2 November 2026**
- Invitations for live audition extended by: Thurs 17 December 2026
- Shortlisted applicants only: Submission of additional required materials by 9.00AM (UK time) on **Thursday 28 January 2027**
- Orchestra audition and panel interview in London: **Sunday 28 February 2027**

Formal offers will be made shortly after the audition date. The successful candidate(s) will need to be available for the dates offered in order to be confirmed as an LPO Fellow Conductor.

Application requirements and audition information

General Qualifications: Applicants must have an extensive background and training in orchestral conducting; demonstrate ability in developing and conducting programmes; possess excellent musicianship and communicative skills. The LPO is committed to the diversity of our community – including the community of conductors – by fostering inclusive and supportive environment and by actively shaping the future of the performing arts.

- I. Complete the [online application form](#), which includes submitting:
 - Applicant contact and demographic information, and any access requirements
 - A statement self-identifying how the applicant is under-represented in conductors of world-class professional orchestras (or video statement covering this information) (100 words)
 - A statement outlining why they'd like to do the Conducting Fellowship and how they are a suitable candidate (max 200 words) (or video alternative)
 - CV (max 3 sides) and biography of max 200 words (or video alternative covering this information). Please do not add any additional documents or endorsements, only the CV and biography.
 - Links to 1 – 2 videos of the applicant conducting a large ensemble. Videos should show the musicians' view of the conductor. (The quality of recording/video itself will not be assessed)

If you are invited for the Orchestra audition:

- II. **Conducting:** Prepare three pieces to conduct the Orchestra in London on Sunday 28 February 2027:

- GRIEG: Piano concerto, mvt 1
- BRAHMS: Symphony no.1, mvt 1
- STRAVINSKY: Danses Concertantes

Each candidate will have up to 20 minutes and may be interrupted by the Principal Conductor who will also announce the exact selection for conducting.

- III. **Programming:** Demonstrate commitment to programming, widening participation and audience engagement through the following task:

Devise a pre-concert Showcase performance (a), and an evening full London Philharmonic Orchestra concert (b), imagining that both are taking place at the Royal Festival Hall on the same evening. Both the pre-concert ensemble and full orchestral performance should fit the LPO's current season theme of '[In Search of Purpose](#)'.

(a) Pre-concert Showcase performance:

A showcase performance for the LPO Junior Artists: a group of 8 talented teenage musicians from backgrounds currently under-represented in professional UK orchestras:

Considering the aim of the LPO Junior Artists programme and instrumentation available, design a 35-minute chamber concert programme for an ensemble of 8 Junior Artists playing alongside LPO musicians.

Full instrumentation available: 2.2.2.2 / 2.2.2.1 / 2P / strings: 3.3.3.2.1

Of which Junior Artists: 1 flute, 1 clarinet, 1 trumpet, 1 trombone, 2 violin, 1 d.bass, 1 percussion

The programme should ensure that the 8 Junior Artists perform in as much as possible. The LPO players do not all need to play in every piece. You do not need to use all the professional players. Your programme should include a range of music, including music by composers of under-represented backgrounds.

(b) Evening concert:

Devise an evening full concert programme for the London Philharmonic Orchestra, imagining this is taking place immediately after the pre-concert performance above. Full orchestral forces would be available. Both Showcase and Evening concert should link with the 'In Search of Purpose' theme.

If you are invited for the audition day, your programming task should be submitted (as PDF or Word doc) by **Thurs 28 Jan 2027**.

You are welcome to add a brief programme note about each performance you devise if you wish, but please do not exceed 100 words for each.

- IV. Interview:** On the audition day, participate in a 15-minute discussion/interview with the audition panel about yourself as a conductor, including responding to any queries about your submission in part III above.
