1st ROUND OF AUDITION:

a) Solo repertoire:

J. S. BACH: Sonatas and Partitas - two contrasting movements freely chosen

- W. A. MOZART: Violin Concerto No. 4 in D Major (KV 218)
- W. A. MOZART: Violin Concerto No. 5 in A Major (KV 219)

<u>b) Orchestral excerpts – 1st Violin:</u> STRAUSS: Don Juan, symphonic poem MOZART: Symphony No. 39 E-flat major – 4th movement

THE DEADLINE FOR APPLICATIONS IS 31st **AUGUST 2025.** Upon receiving the application, the Slovak State Philharmonic Košice will assess whether the applicant meets the conditions for being invited to the audition and will promptly inform the applicant of its decision.

Piano accompaniment in concertos is mandatory. The application must indicate whether the applicant requests the piano accompaniment to be provided by the Slovak State Philharmonic Košice or if they will arrange their own accompanist. In case the applicant requests an accompanist from the Slovak State Philharmonic Košice, they should also send information about the selected concerto along with their application.

Applicants may perform from sheet music.

Slovak State Philharmonic Košice offers the following:

- Salary based on Act no. 553/2003 Coll. on the remuneration of certain employees in the performance of work in the public interest and on the amendment of specific laws, depending on the experience achieved.
- Six weeks of vacation.
- Food allowance.
- Other benefits according to the Collective Agreement.
