## Associate Professor of oboe and chamber music - 50 percent

### About the position

#### Scope and Subject Area of the Position

This is a 50 percent permanent position, available from August 1, 2026.

The academic field of the position is oboe and chamber music. An important part of the role involves talent development, recruitment, and the advancement of the field on a national level. The responsibilities include teaching and mentoring students, research and development (R&D) activities, and administrative tasks related to the academic operations within the section. NMH expects the successful candidate to actively contribute to strengthening artistic and academic collaboration among colleagues.

### Teaching and Mentoring

The responsibilities include teaching and mentoring in oboe and chamber music for both larger and smaller groups, within bachelor's and master's degree programs in accordance with the current curriculum, as well as teaching at lower age levels. Instruction will be provided both as individual mentoring and in group settings. Systematic planning, implementation, and evaluation of teaching are expected.

The position may also include other teaching responsibilities for which the candidate is qualified, including the potential supervision of doctoral-level students.

It is expected that the appointee will take the initiative to plan and lead seminars and courses within their subject area, in collaboration with other faculty members. Additionally, the candidate will participate in the preparation and execution of the academy's entrance auditions and examinations.

### Research and Development Work

The Associate Professor of oboe and chamber music is expected to maintain a high artistic level, primarily through personal artistic practice and participation in research and development projects. It is also expected that the appointee will actively contribute to strengthening R&D efforts and the academic environment at the academy in line with its strategic objectives. The R&D resources associated with the position are expected to be utilized systematically and purposefully, with a primary focus on institutionally relevant projects.

### Administrative Tasks

The appointee will participate in subject-related administrative tasks within their field of expertise and in the broader operations of the academy.

### Qualifications

Through the application and attachments, the applicant must document:

- Artistic qualifications as an oboist at an internationally high level
- Extensive experience as an orchestral musician, chamber musician, and soloist
- Relevant pedagogical experience and proven results from teaching at a high level
- Experience with various concert and communication forms

Further information about the requirements for Associate Professor competency can be obtained by contacting the academy.

The appointee must have Norwegian language skills at a minimum of B2 level or commit to acquiring such skills within three years of employment. The Academy will facilitate language training. Proficiency in Swedish or Danish is considered equivalent to Norwegian. Proficiency in oral and written English is required.

In the assessment of candidates, particular qualifications, characteristics, and experiences that are relevant to the duties of the position - such as the ability to collaborate, take initiative, and implement planned projects - will also be taken into account. We place particular emphasis on the applicant's thoughts and reflections on talent development.

The applicant's ability to be present at the institution and actively contribute to recruitment and community-building efforts will also be emphasized. Weekly presence at the academy is a requirement, and this must be addressed in the application. Applicants should also include a description of their strategy for recruitment of students.

Applicants should enclose an appendix with their application providing a systematic and complete summary of their teaching qualifications in terms of training, courses and/or practical teaching experience. All Associate Professors must have completed a programme for university-level teaching (with a scope of at least 200 hours) or other relevant courses leading to an equivalent qualification. This qualification combined with the candidate's own practical teaching experience will have given them basic skills in terms of planning, executing, evaluating and developing teaching and coaching activities at university level. Completion of the programme will not be weighted in the applicant ranking, but applicants who do not meet the criteria at the time of the appointment will be required to satisfy them within two years of being appointed. The Academy will provide the necessary training.

Applications will be assessed by an assessment committee. The committee will focus primarily on the evaluation of submitted documentation of artistic and teaching qualifications. Initially, we only want applications with CV and any attachments in the form of certificates and diplomas, which are to be uploaded in the digital application portal. After the first assessment of this, we will ask selected candidates to submit additional documentation that they consider may be of importance. Any documentation delivered in physical format, including audio or video recordings, must be submitted in four copies. Shortlisted candidates will be called upon to take part in a trial lecture and an interview.

## General information

The position is subject to the prevailing rules for staff at the Norwegian Academy of Music.

The Norwegian Academy of Music has relatively few female Associate Professors. Women are especially encouraged to apply. In the case of near equivalent qualifications, a female applicant will be preferred over a male applicant.

The government workforce should as far as possible reflect the diversity of the population. In accordance with the Norwegian Academy of Music's equal opportunities policy, we invite applications from all interested candidates regardless of for instance gender, age or ethnicity. People with an immigrant background are encouraged to apply for the position.

The position as Associate Professor is eligible for an annual salary equivalent to from NOK 750,000 to NOK 825,000 in a full time position. For particularly qualified applicants, a higher salary can be considered. 2 percent is deducted in statutory contributions to the Norwegian Public Service Pension Fund.

Please note that information about the applicants may be made public, even if the applicant has requested not to be listed on the public list of applicants, cf. section 25 (2) of the Freedom of Information Act. If so, the applicants will be notified in advance.
