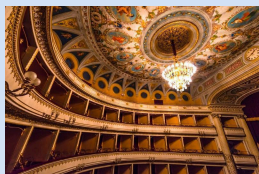

Incomplete applications will not be considered.
For persons needing a visa, register ASAP. Upon completing registration, candidates may request to receive an invitation valid for travel to and stay in Orvieto..

5. Roll call is 19 August at 3pm at Teatro Mancinelli, Corso Cavour 122, Orvieto, Italia

Qualifying round 19-20 August: rehearsal with pianist and singers

Semifinal round 21 August: rehearsal with orchestra and singers

Final Concert and Awards 22 August Teatro Mancinelli at 9 pm

Finalists, on the morning of 22 August, will have 30 minutes to rehearse alone with the orchestra.

At the end of each round, results will be posted on www.spaziomusica.org

6. The winners will be the candidates who have obtained the best score that can not be less than 9/10. The judgment of the jury is final and there is no possibility of appeal. The winner of the first prize, under penalty of forfeiture from the prize itself, which in this case will remain unallocated such that the successive positions of the ranking will remain unchanged, will have to guarantee their presence in Orvieto from 23 to 29 August to take part in rehearsals with orchestra and singers.
7. The winners of the Special Prizes will be selected from among the competitors at the sole discretion of the prize giver.
8. Any legal dispute arising from this agreement will be the exclusive jurisdiction of the Court of Genoa. Only the Italian text will be deemed valid.
9. Jurors are available to provide competitors with feedback
